Big Ideas What enduring understandings are essential for application to new situations within or beyond this content?	Access to valid health information and health-promoting products and services is critical in the prevention, early detection and treatment of health problems.
	The health skill, Access Valid Information, prepares students to be able to critically evaluate the health information around them, whether that is from research articles, advertisements, people, and other print materials. Accessing valid information, products, and services is important in the prevention, detection, and treatment of health problems. Mastery of this skill will empower students to either accept or reject the information they have found in order to achieve better health."
	Accessing valid information, products, and services is important in the prevention, detection, and treatment of health problems. This skill is often the foundation of many decisions students will make. When using this skill, students will be evaluating the validity and reliability of information they have accessed on the Internet, from other printed sources, the media, and other people. Mastery of this skill will empower students to either accept or reject the information they have found in order to achieve better health.
	The accessing information model for grades 6-8 has six steps. The most important parts of this skill is for students to be able to determine the validity and reliability of a resource.
